

## Registration card/ Parent contract

I understand and agree that there is a \$100.00 non-refundable registration fee and a two weeks written notice is needed to end my services. If no notice is given, I am responsible for paying those two weeks. Our billing period is from Monday to Friday. Billing will be completed on Monday mornings. A late fee of \$10.00 will be charged each week that the account is not paid by Monday at the close of business. If payment is not received, children may not attend after Wednesday of that week. If my account with Fresh Start is left delinquent, I understand that my child will be discharged from the program and their place will become vacant. In addition, the account will be turned over to a collection agency after 30 days unless arrangements are made for payment. I understand that the center uses parent engagement app. to communicate all information from the center to the parents. Parent engagement app sure be downloaded when enrollment is completed and childcare begins.

In order for the center to schedule adequate staff and meet the adult / child Licensing ratios, I understand that any changes in my drop-off or pick-up time must be communicated with the Director/ Teacher.
